Pet owner authorizes myself to seek and obtain medical attention and treatment as deemed necessary by a veterinarian. A charge of \$35.00 per hour will apply to wait for owner to arrive home when notified with a serious situation.

It is my policy to accommodate you and your pet(s) with the best possible care while you are away or unable to care for them. A minimum of three walks per week must be booked to maintain service. I do not provide service for aggressive cats/dogs. I do not permit job sharing nor will I use gentle leads.

Service hours: Monday to Friday 8am-3pm. Holiday service by appointment only. Holiday and same day visit/walks cannot be cancelled once booked. Same day service request must be booked by 12 noon and is subject to availability.

If you need to cancel a scheduled visit/walk please do so by 9pm the previous night. If you need to cancel due to weather or illness please do so by 8am that morning, Monday to Friday.

All dogs must wear collars/harnesses and fitted to them properly. All puppies/dogs smaller than 25 pounds should be on a harness. I will only use my own leashes. I must be made aware of any pet that has a history of escaping/separation anxiety/biting.

Any pee/poo accidents before my arrival will be cleaned up. Any pee/poo accidents after my departure will be the sole responsibility of pet owner.

Each visit/walk will be documented paperless by text/email with pictures (weather permitting).

For the safety of your dog(s) and myself, walks will be limited during thunder/lightning/snow/heat and cold below zero degrees and above 25 degrees.

I have a zero tolerance policy for workplace harassment of any kind by family, friends, neighbours, and roommates of clients.
